Kev raug lom los ntawm txhuas nyob rau U.S. ho muaj li cas? Kuv xav hais tias nws kuj tsis yog ib qho teeb meej loj lawm?

Xws li 2004, ntawm me nyuam cov ntshav muaj txhuas 1 txog 5 xyoo tsuas yog 1.4%, tab sis yuav siab me ntsis rau cov me nyuam tuaj tshiab, neeg-Dub, neeg Mev, thiab cov neeg txom nyem.

Feem ntau nyob qhov twg thiaj muaj txhuas?

Qhov uas txhuas mus rau me nyuam lub cev yuav sib txawv los ntawm kev nyob puas ncig, kev coj, thiab kev noj kev haus. Cov tsev qub yog ib yam muaj txhuas, xws li cov muaj xim nti thiab cov av muaj hmoov txhuas. Cov me nyuam Mev yuav raug txhuas lom los ntawm cov hub xa mev teb tuaj, cov qhov noom thiab lwm yam khoom muab txhuas ua los yog muaj kua xeb txhuas. Tej yam tshuaj Mev thiab Es Xias muaj txhuas ntau xws li tshuaj pleev plhu, tshuaj siv rau me nyuam yaus.

Yam khoom ua si twg tau kom muab xa rov qab?

Nyob rau lub yim hlis tim 2, 2007, Fisher-Price tau xa cov khoom ua si rov qab li ntawm 967,000, xws li Sesame Street, Dora the Explorer, thiab lwm yam licensed characters. Tsis tas li ntawd, nyob rau lub yim hlis tim 14, 2007, Mattel tau xa 253,000 khoom ua si rov qab "Sarge" cov tsheb. Nyob rau lub rau hlis tim 13, 2007, RC2 Corporation tau xa li ntawm 1.5 million "Thomas and Friends" cov kev choj hlaus ntoo ua si. Nyob rau lub xyoo no cov khoom raug kom xa rov qab kuj tsawg me ntsis lawm. Yuav ua li cas rau cov khoom raug kom xa rov qab?

Tsis txob pub me nyuam ua si nrog cov khoom raug xa rov qab. Yuav tsum tau qhia cov niam txiv kom muab cov khoom tso xu kev kom cov me nyuam nrhiav tsis tau, txog thaum muab cov khoom xa rov qab los yog muab pov tseg raws li tsoom fvv saib xyuas kev noj qab haus huv qhia.

Kuv yuav qhia cov niam txiv li cas txog ntawm cov khoom ua si uas tseem tsis tau xa rov qab?

Nws kuj nyuaj kawg qhov teb txog cov khoom me nyuam muaj tsuas yog saib lawv puas hu xa rov qab. Niam txiv yuav tau saib ntawm Consumer Product Safety Commission (CPSC) Web site <http://www.cpsc.gov> rau yam khoom kom xa rov qab thiab me nyuam cov saw coj ua si.

Ua li cov khoom kuaj rau txhuas nyob tom tsev ne?

Niam txiv yuav tau nug cov khoom siv kuaj me nyuam cov khoom ua si tom tsev, xim, puas plav, los av. Kev tshawb fawb tau qhia tias cov khoom no nws qhia tsis tshua meej txog kev sib txawv txav txog ntawm qhov muaj txhuas ntau thiab tsawg.

Ua li kuv ho muaj feem xyuam ua dab tsi thiab xws li tus kaws kho mob? Kuv yuav hu leej twg pab los yog thaum muaj tshwm sim?

Cov kws kho mob muaj feem xyuam kuaj tshav rau cov me nyuam txog txhuas rau txhua tus me nyuam hnuv nyug li ntawm ib xyoo thiab li ob xyoo. Yog koj muaj lus nug txog qhov kev tshoj ntshuam thiab qhov kev tus me nyuam raug lom los ntawm txhuas, koj hu tau rau qhov chaw saib xyuam raug tshuaj lom ntawm 1-800-222-1222. Lawv yuav pab koj sab laj sib tham seb yam tshuaj twg thiaj daws tau.
